#### Traffic

- The pre-Christmas rise in COVID cases delayed the start of staff interviews

#### COVID-19

- Current NHS COVID plan is still in effect.
  - Key Things to Remember
    - Keep children at home until they are no longer symptomatic.
    - Parents of children who are symptomatic will be asked to pick up their child if they are symptomatic at school.
    - Classes will be sent home for remote learning if a positive case is identified in the classroom.
- No new guidance from AHS has emerged other than schools will be tracking cases and doing their own contact tracing.
- The Government of Alberta will be supplying rapid tests and masks to schools, starting the week of January 10. Two 5-test kits will be supplied to each student and staff member (five weeks of testing). The first kit will be supplied by the end of next week.
