Auditor's Recommendations

- As a result of finding an error that was related to the creation of the statements and not the actual entries in the General Ledger, Auditor, Jennifer Michaud, recommended implementing financial software, such as QuickBooks, to avoid such errors in the future. Errors like this occur due to the manual nature of creating statements in Excel, which can be prone to human error given the size and volume of transactions the organization is handling. (This was an error of \$0.31).
- Auditor, Jennifer Michaud, offered to do a preliminary check in part way through the year to catch any discrepancies before the audit and, henceforth, make the audit faster/easier.
- Recommendations will be taken into consideration, researched, and will be brought forward at a regular FANHS meeting.

FANHS sincerely thanks our auditor, Jennifer Michaud, for her time and work done on the financial review. We appreciate her feedback and are grateful for her participation in completing the financial review ahead of our deadline.
